AB 22-18 Mountain View RV Park – Water Connection

- Tim Farrow requesting, on behalf of Mountain View RV Park, city water service. Allow City Water System connection to Mountain View RV Park, outside of City Limits. Future agreements and conditions to be set by City Council, meeting all city requirements.
